Resolved: Following an amendment, the minutes of the meeting of the Council held on 17th October 2016 were confirmed as a true record and signed by the Chairman.

Planning Applications

Resolved: The Clerk should inform St. Helens Council that the Council raises no objection to the following applications:

Resolved: The Clerk should inform St. Helens Council that the Council objects to application P/2016/0817/FUL (Barrows Farm, Carr Mill Road) and the retrospective application for the erection of hardstanding for the storage of plant and machinery. It has concerns about highway safety resulting from this development.

Resolved:

The Council agrees to make a grant of £400 under s137 of the Local Government Act 1972 to the Residents Association, towards the cost of two Christmas parties. (Councillor Roberts left the meeting during this item).

Proposed Playground at Douglas Avenue

Councillors received five quotations for the development of a proposed playground on Douglas Avenue. It was resolved:

- Request St Helens Council to apply for planning permission to proceed with the play area.
- Request St Helens Council to inspect and maintain the play area, on an annual basis.
- Request the Clerk to make arrangements to implement these decisions.
- Inform residents through an announcement on the website and an e-mail to everybody who responded to the consultation.

It was resolved that the Council will proceed with the proposed survey in the new year, with an announcement in the Beacon with links to an online version of the survey. It was also agreed to offer prizes of up to £100 in total in a draw of those completing the survey.
